CHARITABLE SOLICITATIONS BOND

KNOW ALL MEN AND WOMEN BY THESE PRESENTS:

That we, _____ of _____
_____ as Principal, having filed a Notice of Solicitation with the Vermont
Attorney General in order to solicit charitable contributions in the State of Vermont, and
_____ of _____
as Surety, are held and firmly bound to the State of Vermont and to any person who may have a cause of
action against the Principal for any liabilities under the Vermont Charitable Solicitations Law, title 9
Vermont Statutes Annotated chapter 63, subchapter 2, arising out of the conduct of business in or into the
State of Vermont by the Principal as Paid Fundraiser, in the sum of Twenty Thousand Dollars (\$20,000.00)
lawful money of the United States of America, to be paid to the State of Vermont for its own use, and to
any person who may have a cause of action against the Principal, for any such liabilities as their interests
may appear, not exceeding in the aggregate the same sum of Twenty Thousand Dollars (\$20,000.00), for
which payment will truly be made. To this end, and to this degree, we bind ourselves, our heirs, executors,
administrators, successors and assigns, jointly and severally by these presents.

The condition of this obligation is such that if the above Principal shall act as Paid Fundraiser in
accordance with the law and faithfully comply with the provisions of the Vermont Charitable Solicitations
Law, and if the Principal shall fully indemnify and save harmless from loss the State of Vermont and any
person who may have a cause of action against the Principal as Paid Fundraiser for any liabilities under the
Vermont Charitable Solicitations Law, then this obligation shall be void, otherwise to remain in full force
and effect.

This bond shall not become void upon the first recovery thereon but may be sued upon from time
to time until the full amount thereof has been exhausted.

This bond is to cover all claims arising under the Vermont Charitable Solicitations Law on
account of the Principal's activities as Paid Fundraiser in or into the State of Vermont for the full term
hereof beginning on the date of the Principal's Notice of Solicitation. Any action on the bond must be
brought within two years after accrual of the cause of action.

In no event shall the aggregate liability of the Surety on this bond exceed Twenty Thousand
Dollars (\$20,000.00) in its entirety, and payment by the Surety of one or more claims shall reduce the penal
sum of this bond to the extent of such payment or payments.

Regardless of the number of years this bond shall continue in force and the number of premiums
which shall be payable or paid, the Surety's total limit of liability shall not be cumulative from year to year
or period to period.
