COMPLAINT

Plaintiff, the State of Vermont, by and through Attorney General William H. Sorrell, for its Complaint against Defendant Dean R. Corren alleges as follows:

Nature of the Action and Legal Framework

1. This is an action brought by the Attorney General on behalf of the State of Vermont seeking enforcement of statutes governing the system for public financing of election campaigns in Vermont's campaign finance law.

2. Pursuant to Vermont's public financing option, a candidate for the office of Lieutenant Governor who raises at least \$17,500.00 from no fewer than 750 individuals who each make a contribution that does not exceed \$50.00 will qualify to receive campaign finance grants of public money in amounts up to \$32,500 during the primary election period and \$150,000 during the general election period to fund his or her campaign for election. 17 V.S.A. §§ 2964, 2965(b).

3. Once a candidate qualifies for public financing and receives campaign finance grants, he or she may not solicit, accept, or expend any additional contributions that were not part of the qualifying contributions or the public financing received. 17 V.S.A. § 2963(b)(1).

4. A publicly financed candidate who violates the prohibition against soliciting, accepting, or expending additional contributions “shall refund the unspent balance of Vermont campaign finance grants received . . . as of the date of the violation.” 17 V.S.A. § 2903(b).

5. Under Vermont law, a contribution is defined as “a payment, distribution, advance, deposit, loan, or gift of money or anything of value, paid or promised to be paid for the purpose of influencing an election . . . or supporting or opposing one or more candidates in any election.” 17 V.S.A. § 2901(4). The definition of a contribution does not include “costs paid for by a political party in connection with a campaign event at which three or more candidates are present.” *Id.* § 2901(4)(L).

6. Under Vermont law, a contribution includes “a related campaign expenditure made on the candidate’s behalf.” A “related campaign expenditure” is defined as “any expenditure intended to promote the election of a specific candidate” that is “intentionally facilitated by, solicited by or approved by” the candidate or the candidate’s campaign committee. 17 V.S.A. § 2944(a),(b).

7. An expenditure made by a political party that primarily benefits six or fewer candidates for state office who are associated with that political party is

subject to a rebuttable presumption that it is a related expenditure made on behalf of those candidates. 17 V.S.A. §§ 2944(c)(1), 2901(1).

8. A candidate who is the beneficiary of a related campaign expenditure must report that related expenditure as a contribution received on his or her campaign finance reports filed with the Secretary of State. 17 V.S.A. §§ 2962-2964.

9. In connection with the 2014 election, Dean R. Corren voluntarily sought public financing for his campaign for election to the office of Lieutenant Governor.

10. Corren qualified for public financing and received \$180,717 in campaign finance grants. Accordingly, Corren was prohibited from receiving contributions or spending money on his campaign from other sources.

11. Notwithstanding this prohibition, Corren solicited assistance in the form of in-kind contributions for his election campaign from the Vermont Democratic Party ("the VDP"). Corren's campaign manager, Megan Brook, worked with the VDP's Executive Director, Julia Barnes, to write a mass email that expressly advocated for Corren's election. The VDP sent this email on October 24, 2014, to approximately 19,000 supporters. The value of the email was estimated by the VDP to be at least \$255. The mass email was a related expenditure made by the VDP on Corren's behalf and therefore is considered a contribution to Corren. Corren did not report the VDP's contribution on his campaign finance reports filed with the Secretary of State.

12. Such conduct by Corren violated Vermont campaign finance law.

Parties and Jurisdiction

13. The Attorney General has the authority to enforce Vermont's campaign finance laws on behalf of the State of Vermont pursuant to 17 V.S.A. § 2903. Accordingly, this Court has jurisdiction over this matter pursuant to 17 V.S.A. § 2903.

14. The State of Vermont has its principal offices in Montpelier, Vermont. Venue is proper in this Court pursuant to 12 V.S.A. § 402.

15. Dean R. Corren is a natural person who was a candidate for election to the office of lieutenant governor of the State of Vermont on November 4, 2014. He resides in Burlington, Vermont. In order to conduct his gubernatorial campaign, Corren formed a candidate committee and was responsible for its actions.

Background Facts

16. Julia Barnes was Executive Director of the Vermont Democratic Party in 2014.

17. Dottie Deans was Chair of the Vermont Democratic Party in 2014.

18. Megan Brook was campaign manager for Dean Corren's lieutenant governor campaign in 2014.

19. On October 27, 2014, the Attorney General's Office received a complaint about an email sent by the VDP on October 24, 2014, advocating for the election of Dean Corren.

20. On October 30, 2014, the Attorney General's Office informed Corren that it had received a complaint regarding the October 24, 2014, mass email and

that it appeared the email was a contribution to the Corren campaign in violation of the conditions on campaign finance grants.

21. The State conducted an investigation into the complaint. The investigation included obtaining documents from the Corren campaign and the VDP. The Corren campaign provided the State with a series of emails exchanged between Megan Brook for the Corren campaign and Julia Barnes and Dottie Deans for the VDP.

22. On September 26, 2014, Corren wrote an email to Dottie Deans, copying Megan Brook, stating in part: "I want to let you know how much I appreciate all of your personal support and all the time your staff is putting in to navigating some uncharted waters. After our Wednesday meeting I was encouraged that we might be able to find a way forward that works for all of us. As I hope I've made clear, I need your help if I'm to have any shot of replacing Phil Scott, so I can really help work for the issues we care about." Attached as Exhibit 1.

23. On September 30, 2014, Brook wrote an email to Julia Barnes in which she asked the following: "Wondering if there is opportunity to do and [sic] email from Dottie or you introducing everyone to the D candidate for Lt. Governor? ... It could simply say to get your Dean Corren lawn sign email volunteer@DeanCorren.com. If you can't do that can this be posted on the FB page at some point? Still searching for the best way to engage that doesn't have any barriers at this point. Attached is a jpeg of the sign in case you can do anything." Attached as Exhibit 2.

24. Brook followed up with an email to Barnes and VDP Chair Deans on October 10, 2014 in which she wrote: "Wondering how the idea of an email message to Dems is coming along." Attached as Exhibit 2.

25. The same day, Barnes replied to Brook, with a copy to VDP Chair Deans, in which she wrote: "Can you draft something that you would like us to send from Dottie to the list. We can then review it and make edits." Attached as Exhibit 2.

26. On October 13, 2014, Brook sent Barnes and VDP Chair Deans an email with the subject "Email message about Dean." In the message she wrote: "Thank you for sending a message about Dean to your email list. I have tried my best to put something together for you but don't know the style of your messages or how you usually communicate. Feel free to edit liberally. Let me know if I can help in other ways and please send me a copy when it goes out, I'm not on the Dem list." Following this introduction, she provided six paragraphs of text about Dean Corren for use in an email from the Vermont Democratic Party to its list. Attached as Exhibit 3.

27. On October 16, 2014, Barnes sent a message to Brook and VDP Chair Deans that said, in part, "Spoke to both of you on the phone – to be clear, we will hold on the letter until Dottie films the ad on Monday. If there are other requests of the VDP, please send them in writing to me so that we can fit them into the already packed email schedule." Attached as Exhibit 2.

28. On October 23, 2014, at 5:58 PM, Barnes sent an email to Brook, with a copy to VDP Chair Deans, with the subject "Corren Email Blast." She wrote, in part: "I sent the email to our lawyer to have it approved (he checks everything because of the public financing) and he said it does not qualify as an exemption from the contribution definition because the email list has value. I am trying to find out how little we could charge you to 'rent' the email list. It's 19,000 people. We do very much want to do this – I'm sorry this is an obstacle." Attached as Exhibit 4.

29. The following morning, on October 24, 2014, at 8:59 AM, Brook responded to Barnes and VDP Chair Deans in an email with the subject "Corren Email Blast." She wrote: "It is so frustrating that we keep running into these blocks as I know the law is not designed to punish those who receive campaign financing so there has [sic] to be a way to resolve this. I have two ideas below that should put us into compliance so we can move forward." Attached as Exhibit 5.

30. The first idea proposed by Brook was for the email to mention more than six candidates, presumably to avoid the related-expenditure presumption that attaches to expenditures that primarily benefit six or fewer candidates. Brook's second idea was for the Corren campaign to pay for the value of the email blast. In that regard, Brook asked Barnes how "much of an in-kind contribution did you attribute to the Shumlin campaign in the recent blast about the events with Bernie [Sanders]?" and offered to "work off the same price point." Attached as Exhibit 5.

31. Barnes responded one hour later, on October 24, 2014, at 10:00 AM, with the subject "Corren Email Blast." She wrote: "First idea is perfect! Thanks Meg! We'll get it out today." Attached as Exhibit 5.

32. At 12:47 PM on October 24, 2014, VDP Chair Dottie Deans sent a mass email message to 16,000 to 19,000 people using a mailing list powered by NGP VAN, Inc. with the subject: "How you can help me help Dean Corren." The text of this email message is attached as Exhibit 6.

33. At 12:48 PM, Barnes forwarded the email described in paragraph 24 to Brook and said: "This just went out." Attached as Exhibit 6.

34. Brook did not reply that day to the email from Barnes to object to the form or language of the mass email sent by Dottie Deans to the VDP list.

35. The October 24, 2014, mass email sent by Dottie Deans included several verbatim phrases and sentences from the draft email that Brook sent to Barnes and Deans. Furthermore, the structure of the email was substantially similar to the draft that Brook had given to Barnes and Deans.

36. For example, in her October 24, 2014, email, VDP Chair Deans begins, "Many of you know I'm a strong supporter of Dean Corren for Lt. Governor but maybe you don't know why. Dean has the skills and experience to support our Vermont Democratic Party Platform and overcome some of the greatest challenges we face." Attached as Exhibit 6.

37. After referring to some of Mr. Corren's positions on campaign issues, VDP Chair Deans continues, "I believe Dean would make an excellent Lt. Governor,

but to make this happen we all need to pitch in. Here are a few ways you can help.”

Attached as Exhibit 6.

38. The October 24, 2014, mass email mentions two state candidates (Governor Peter Shumlin and Dean Corren) and one federal candidate (Congressman Peter Welch).

39. Based on the subject line regarding “helping” Dean Corren, the three initial paragraphs expressly advocating for Corren’s candidacy as Lieutenant Governor, and the link encouraging recipients to volunteer for Corren’s campaign, as well as the earlier requests for such an email to Barnes and Deans by Brook, it is clear that the primary purpose of the October 24, 2014, email blast was to urge voters to support Corren’s campaign and elect him to office, and not simply to invite them to attend a “Get Out The Vote” rally.

40. At no time between October 24 and October 30, 2014, did Brook ask the VDP what the value was of the October 24, 2014, email blast. Furthermore, the Corren campaign did not attempt to pay the VDP for the value of the email blast at any time between October 24 and October 30, 2014.

41. On February 26, 2015, the Attorney General met with Corren and his legal counsel to discuss the potential violations uncovered in the investigation. At that meeting, the Attorney General gave Corren and his counsel a draft of the campaign finance enforcement complaint that the State intended to file in Superior Court.

42. During the following three and a half weeks, the Attorney General's Office exchanged communications with Corren's attorney in an attempt to resolve the matter through negotiation. No resolution was reached.

43. The Attorney General's Office reached an agreement with the VDP to settle the State's claims against the VDP arising out of the activities described herein.

COUNT I
(Corren Solicited and Accepted Contribution
in Violation of Terms of Public Financing)

44. Plaintiff repeats and realleges the allegations contained in Paragraphs 1 to 43 above, as if fully set forth herein.

45. Dean Corren raised \$19,283 in qualifying contributions during the Vermont campaign finance qualification period for 2014.

46. On June 12, 2014, Corren signed and filed a campaign finance affidavit with the Secretary of State in accordance with 17 V.S.A. § 2892. Megan Brook also signed that affidavit as treasurer of the Corren campaign. The affidavit is attached hereto as Exhibit 7.

47. In that affidavit Corren certified that he had "read and complied with and will continue to comply with all the conditions set out by law for receiving public finance grants under 17 V.S.A. § 2981 to 2985."

48. Corren also certified that from the date the affidavit was signed he would not solicit, accept, or expend any contributions other than qualifying

contributions, Vermont campaign finance grants, or other contributions authorized under 17 V.S.A. § 2895.

49. Corren further certified that he was “aware of the penalties for failure to abide by this affidavit agreement which are set forth in 17 V.S.A. § 2903.”

50. Because Corren was successful in the primary election and ran in a contested general election, he was not permitted to solicit, accept, or expend contributions specified in 17 V.S.A. § 2985(c). Thus, the only contributions he was permitted to solicit, accept, or expend were qualifying contributions received before June 12 and the Vermont campaign finance grants.

51. Corren received a Vermont campaign finance grant of \$30,717 in public money for the primary election period to fund his campaign for election. He received a Vermont campaign finance grant of \$150,000 during the general election period to fund his campaign for election.

52. As a condition of receiving these Vermont campaign finance grants, Corren was prohibited by 17 V.S.A. § 2983 from soliciting or accepting contributions or spending money on his campaign from other sources.

53. The mass email was a related expenditure under 17 V.S.A. § 2944(b). Corren’s campaign manager, Megan Brook, intentionally facilitated and solicited the VDP to send the email message. Pursuant to § 2944(a), this related expenditure is considered a contribution to Corren, the candidate on whose behalf the expenditure was made.

54. Corren violated 17 V.S.A. § 2983 by soliciting and accepting the in-kind contribution of the email blast sent by the VDP on October 24, 2014.

55. Upon information and belief, as of October 24, 2014, Corren had approximately \$52,000 remaining in unspent Vermont campaign finance grants.

COUNT II
(Corren Failed to Report Contribution Received from VDP)

56. Plaintiff repeats and realleges the allegations contained in Paragraphs 1 to 55 above, as if fully set forth herein.

57. Dean Corren filed a campaign finance report with the Secretary of State's Office on or about November 3, 2014. In that filing, Corren did not report the in-kind contribution received from the VDP through the related expenditure of the October 24, 2014, mass email.

58. According to the VDP, the value of the October 24, 2014, email blast was at least \$255.00.

59. Vermont law requires a candidate to report all contributions received during the relevant reporting period. 17 V.S.A. §§ 2962-2964. Specifically, the law requires that candidates itemize all contributions received in excess of \$100, listing the name of the contributor, the date, and the amount received. *Id.* § 2963(a)(1).

60. Corren's failure to report the contribution from VDP violated 17 V.S.A. §§ 2962-2964.

CLAIMS FOR RELIEF


WHEREFORE, the State of Vermont respectfully requests that the Court award it the following relief:

1. Enter an Order that Defendant Dean Corren violated Vermont's campaign finance laws by soliciting and accepting a campaign contribution in violation of 17 V.S.A. § 2983(b);
2. Enter an Order that Defendant Dean Corren violated Vermont's campaign finance laws by failing to report a campaign contribution in violation of 17 V.S.A. §§ 2962-2964;
3. Assess a civil penalty and enter a judgment in the amount of \$10,000 against Defendant Dean Corren and in favor of the State of Vermont for each violation in Counts I and II;
4. Order that Defendant Dean Corren refund the amount of the Vermont campaign finance grant unspent by him as of October 24, 2014; and
5. Award the State of Vermont any such other legal and equitable relief as may be just under the circumstances.

One of the challenges for us is trying to decipher the intense legal hurdles without knowing as much as we should. For example, it's clear you all are uncomfortable with any buy-in coming solely from my campaign. This seems to be where the issue of itemized receipts comes into play. However, in chatting with Doug Hoffer (a close friend for years) he said he's only ever paid into the coordinated campaign with his own campaign funds and has never received an itemized receipt. We also know that both Senators Leahy and Sanders are or have made contributions this year. Clearly, there is the ability to take money even from campaigns that are not receiving a direct benefit.

I understand there are several layers to this challenge, both legal and political. I will continue to work on the political front, talking to all the candidates involved. In the meantime, I'd like to connect our attorneys. Clearly, I would like this resolved to everyone's satisfaction, and if at all possible, in a way that allows me to win. At the moment, I'm operating at a serious knowledge deficit, so connecting our attorneys would be a big help.

My attorney is Dan Richardson at Tarrant, Gillies, Merriman & Richardson in Montpelier. If Dan could reach out to your DC attorney or Joshua Diamond in Montpelier, I would be grateful. Please let me know if this is possible.



If you mention over six candidates and the email will count as a party function as defined in Vermont statutes. If you can't include Welch because of Federal rules, Rep. Kesha Ram could count as the 7th candidate (in addition to the 6 members of your statewide slate) either sharing the Corren video that includes her or last week's VT Edition.

Alternatively, while keeping a careful eye on our budget, we are willing to pay for anything we receive of value. How much of an in-kind contribution did you attribute to the Shumlin campaign in the recent blast about the events with Bernie? We could work off the same price point. You mentioned there would be other candidates included in this email so presumably we could divide the value across the number of candidates.

Hope one of these ideas is acceptable and we can move forward quickly with the message. The momentum is building and a message to your full list would really help.


