**NOTICE OF DATA [Extra1]**

Dear Sample A. Sample:

NSi Industries, LLC (“NSi”) is writing to make you aware of an incident that may affect your personal information. We take the security of personal information in our care seriously and are providing you with this notice to make you aware of the incident and provide information on the steps we are taking in response and the steps you may take to help protect your personal information, should you feel it is appropriate to do so. We likely have your information because you are related to a current or former employee of NSi.

**What Happened?** In October 2023, NSi identified unauthorized activity affecting certain servers and devices in our network. We promptly took steps to secure our systems and commenced an investigation to determine the nature and scope of the activity. On October 30, 2023, we determined that certain HR information related to some current and former employees, as well as beneficiaries and dependents, that was stored within the impacted servers was potentially copied from the system between October 11<sup>th</sup> and 15<sup>th</sup>, 2023. Following this determination, we promptly began taking steps to determine what information may be affected. This involved a comprehensive review of the relevant documents to determine what information was present in those files and to whom it relates. We recently completed this review and determined that your information was in the relevant files.

**What Information Was Involved?** Our investigation determined that the relevant files may have included information from an HR records, such as: name; [Extra2].

**What We Are Doing.** We take this incident and the security of personal information entrusted to us very seriously. In response to this incident, we promptly began an investigation and took steps to secure our system. We also notified federal law enforcement. NSi has security measures in place to protect information in our care and we continue to take steps to enhance the security of our systems. We are also providing you with the attached *Steps You Can Take to Help Protect Personal Information* that includes resources and information to help you protect against potential misuse of your information. Additionally, NSi has secured the services of Experian to provide you with credit monitoring and identity restoration services for 24 months, at no cost to you. More information on how to enroll in these services can be found in the enclosed *Steps You Can Take to Help Protect Personal Information*.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring free credit reports for suspicious activity and to detect errors. We also encourage you to review the enclosed *Steps You Can Take to Help Protect Personal Information* and enroll in the credit monitoring and identity restoration services we are offering.

### Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for twenty-four (24) months.

If you believe there was fraudulent use of your information and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. ## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

## **Additional Information**

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
