#### **RE: NOTICE OF DATA << Variable Data 1>>**

Kevin Grunawalt/Verso Financial is writing to make you aware of a data privacy event that may affect some of your personal information. This notice provides you with details about the event, our response, and resources available to you to help protect your information, should you feel it is appropriate to do so.

What Happened? We were made aware of suspicious activity involving an employee email account and, in response, we initiated an investigation into the nature and scope of the activity. From that investigation, it was determined that the email account had been subject to unauthorized access by an unknown actor at times between October 2023 and February 2024, during which the unknown actor had the capability to copy contents of the mailbox. We subsequently began an extensive review of the email account to identify and catalogue what information was present within the account and to whom that information related. Following the completion of that review, on or around August 23, 2024, we moved promptly to locate and confirm addresses for affected individuals in order to provide necessary notifications.

**What Information Was Involved?** Your name and the following types of information relating to you were identified as having been present within the email account at the time of the event: <<Breached Elements>>.

What We Are Doing. We take our responsibility to safeguard the data entrusted to us very seriously. We responded promptly to this event and worked diligently to conduct a comprehensive investigation and thoroughly review the information potentially affected. We are also taking steps to enhance our existing security measures to further protect the data in our care moving forward. As an added precaution, we are providing you with access to twelve (12) months of complimentary Equifax credit monitoring services provided through Epiq Global. Information on how to enroll in these services is provided in the attached *Steps You Can Take To Protect Personal Information*. This section also includes guidance on resources available to you to protect personal information against potential misuse.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors for at least the next 12 to 24 months. We also encourage you to review the attached *Steps You Can Take To Protect Personal Information* and enroll in the credit monitoring services we are offering. Please note, we are not permitted to enroll you in these services and so you will need to follow the instructions included below to enroll.

### **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit <a href="www.annualcreditreport.com">www.annualcreditreport.com</a> or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
