### High Water Sinks State Islands

[SPECIAL TO PAPER]

HUDSON FALLS, N. Y., Nov. 17.--Destruction of State islands in Lake George by high water caused by the dam of the International Paper Company at the outlet of the lake, will be prevented in the future as the result of an agreement just made by Conservation Commissioner George D. Pratt with the International Paper Company, under which the water gates of the dam are to be operated to hold the maximum height of the broad lake at an elevation not to exceed eight inches above the crest of the dam. While made primarily in the interest of the State islands, the agreement with the International Paper Company to waste water through its gates will have the effect of annually preventing much damage to private docks throughout the entire extent of the lake.

High water at Lake George has caused extensive damage each spring for many years even to the extent of the threatened loss of many of the beautiful islands. The matter was taken up for thorough study by the engineers of the conservation commission and by the Attorney-General's office with the result that the International Paper Company voluntarily offered to enter into a definite agreement to use all of the facilities available at their mill to control the level of the lake. The agreement for a two-year period of trial in the control of the level of the lake is made without prejudice to the rights of either party with the understanding that at the end of that time steps will be taken, based on data collected during the two-year period which it is expected will end for all time the annual damage to both State and private property in the lake.
