Hi Kayla,

Nice to "meet" you by phone yesterday. Set forth below is what I believe to be our agreement regarding your public records request after discussing the challenges presented by the request(including that it seeks documents beyond those possessed by the Attorney General's Office("AGO") because some of the requests are not specific enough for us to be able to do reasonable searches, and because they are unlimited in time).

Request No. 1-The AGO will search for agreements or contracts for its retention of the listed firms.

Request No. 2- The AGO will search for non-privileged records that reflect payments or disbursements made by the Vermont Attorney General's Office to the listed firms.

Request No. 3- The AGO will search for documents that reflect the appointment by the AGO of any attorney in the listed firms as a Special Assistant Attorney General.

Request No. 4- The AGO will search for agreement or contracts for the retention of counsel regarding opioids or insulin. As I mentioned, "insulin" may be too broad for a search because of the number of subjects it covers, but we will try, and to the extent that we are able to include "pharmaceutical pricing" in the search, we will do so. Request No. 5-- The AGO will search for records that reflect payments or disbursements made by the Vermont Attorney General's Office to a law firm that has been retained regarding opioids, insulin or pharmaceutical pricing, with the same caveat as in Request No. 4.

Request No. 6-The AGO will search for records that relate to the appointment of a lawyer or law firm other than those listed in Request No. 1 regarding opioids, insulin, or pharmaceutical pricing, with the same caveat as in Nos. 4 and 5.

Only Request No. 2 specifically seeks "non-privileged" records. Am I correct that applies with respect to the other requests as well, given that we are unable to produce privileged records?

Our office has closed today because we lost power and Dec. 26, 2022 is a holiday. Let's find a time next week to further discuss Request No. 7 and the issue presented by the unlimited time frame in your requests.
