Good Afternoon Charity,

I have a legal question that popped up this week and I hope you or your office can help answer it before February 3rd. This is when the NH Legislative Committee is taking up language in regards to our tribe. So here is the context and question.....

Nulhegan has a number of Abenaki Citizens who live in NH. These citizens are not currently represented in NH state government because there are no recognized tribes in NH. Our Vermont recognition does not extend into NH law so the NH Legislature is considering "recognizing" the Nulhegan Abenaki Tribe this session which would allow us to represent our NH citizens within state government there.

My interpretation of the VT statutes below suggest that if NH recognizes Nulhegan as an Abenaki Indian Tribe in NH, it would NOT affect our VT Recognition status. Is that a correct interpretation? I base this interpretation on the fact that the criteria listed in statute is part of the application process for consideration for recognition and not an on-going requirement after recognition has taken place. Especially when Abenaki are starting to feel ok with coming forward 10 year later and we have communities needing representation throughout our homelands.

The Section below is listed for your convenience and I hope you agree with my assessment.
