On February 17, 2023, on behalf of Southwestern Vermont Health Care Corporation ("SVHC")/Southwestern Vermont Medical Center, Inc. ("SVMC"), you provided notice to our Office of the Affiliation and Integration Agreement as between Dartmouth-Hitchcock Health ("D-HH") and SVHC/SVMC. To the extent the proposed transaction constitutes a transfer of "all, or substantially all" assets by SVHC, SVMC, the SVHC Foundation, and/or each VT non-profit SVHC Affiliate pursuant to 11B V.S.A. § 12.02(g), our Office has reviewed it as such.

In support of your notice, you provided, and my Office has reviewed, the following documents:

- The Affiliation and Integration Agreement as between D-HH and SVHC/SVMC dated December 5, 2022;
- The Articles of Incorporation and Bylaws of D-HH, SVHC, SVMC, the SVHC Foundation, Mount Anthony Housing Corporation, and SVHC Realty, Inc.;
- Various Resolutions of the respective Board of Trustees of SVHC, SVMC, and SVHC Foundation, Inc.;
- A February 7, 2023 correspondence from the CFO of SVHC regarding donor restricted funds held by the SVHC Foundation and by SVHC-Hoosick Falls LLC; and

• Your letter of February 17, 2023, concerning the parties' agreements that all donor restricted gifts received by any of the relevant entities will be used as directed by donors, and that all unrestricted gifts to said will be used for the benefit of the communities now served by SVHC and SVMC.
