Dear Sample A. Sample:

The purpose of this letter is to notify you regarding a recent data event that we believe involves some of your data. This notice provides you with information regarding the event, our response, and additional steps you may wish to take to protect your information, should you determine it is appropriate to do so.

What Happened? Jeffries Morris, Inc. (“JMI”) discovered unusual activity on certain of its computer systems. JMI promptly isolated these systems and carried out an intensive investigation with the assistance of third-party forensic specialists. The investigation determined that there had been unauthorized access to the JMI network on or about January 20, 2023, and JMI evaluated its systems to determine the type of information affected and to whom it related. Following its initial review, JMI worked diligently to identify potentially affected individuals. On April 11, 2023, JMI completed its internal review to identify potentially affected individuals, following which contact information was developed to provide notification to these individuals.

What Information Was Involved? We can advise you that some of your data including name and Social Security number may be involved. This is the first time our organization has been affected by such an incident.

What We Are Doing. (1) We are notifying relevant regulators as required. (2) While we do not have any indications that fraud or identity theft has occurred as a result of this incident, as an added precaution we are offering you ## months of complimentary credit and identity monitoring through Experian, the country’s leading credit monitoring service provider. If you wish to receive this service gratis, you may enroll by following the below-described instructions.

What You Can Do. JMI encourages you to remain vigilant against incidents of fraud by reviewing your account statements carefully, and by monitoring your free credit reports for suspicious activity, should decide to you avail yourself of this service. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Experian, Equifax, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
