I left you a voicemail but wanted to follow up here. State police told me that I needed to make my records request for the Newfane video to the Attorney General's office. They cited that the statewide use of force policy adopted by the criminal justice council says that if a prosecutor brings a charge, the prosecutor's office controls the release of the video and is the agency that I should make my records request too.

If my request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions outlined in 1 V.S.A. § 317.

If parts of the records are exempt from release, I ask that you redact the exempt sections and release the rest of the record.

In the event that there are fees, please inform me of the total charges in advance of fulfilling my request. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest. The requested documents will be used by Vermont Public and not for commercial purposes.
