Dear Sample A. Sample:

Optical Cable Corporation (“OCC”), like many organizations across the country, has unfortunately been the victim of ransomware attack. We are writing to share with you how this incident may have affected your personal information and, as a precaution, we are providing you with steps you can take to protect this information. OCC takes the privacy and security of your personal information very seriously and we sincerely regret any concern this incident may cause you.

**What Happened and What Information Was Involved**

On or about June 20, 2023, we were alerted to suspicious activity affecting our network. We launched an immediate investigation to determine the nature and scope of the activity, including engaging leading outside cybersecurity experts to investigate and remediate the incident. Based on this investigation it quickly became apparent that OCC was the victim of a ransomware attack led by cybercriminals.

Our team of experts was able to recover from this matter and successfully continue operations safely. However, based on the nature of this attack, the cybercriminal claims to have copied certain files from our servers including a limited number of files that could possibly contain some personal identifying information (such as name, social security number, passport number, and/or driver’s license copy). **We have no evidence that confirms any success of this cybercriminal’s claims and actions. However, we want to operate with an abundance of caution.**

**At this time, there is no reason to believe that personal information has been misused. However, the OCC Recovery Team has arranged for two years of free credit monitoring in addition to Experian’s ID protection services. Again, this is a precautionary measure offering ID protection services retroactive to the date of the incident.** More information about the free credit monitoring services we are providing through Experian can be found in the attached Identity Theft Protection Guide and Information.

**What We Are Doing**

Upon discovering the incident, we began an investigation and engaged leading outside cybersecurity experts who assisted us in further investigating and remediating the incident. We have notified the FBI’s Cyber Crimes Division and the Cybersecurity and Infrastructure Security Agency (CISA) of this incident

When you receive your credit reports, review them carefully. Look for accounts or creditor inquiries that you did not initiate or do not recognize. Look for information, such as a home address and Social Security number that is not accurate. If you see anything you do not understand, call the credit reporting agency at the telephone number on the report.

**For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents:** You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

\* Offline members will be eligible to call for additional reports quarterly after enrolling.

\*\* The Identity Theft Insurance is underwritten and administered by American Bankers Insurance Company of Florida, an Assurant company. Please refer to the actual policies for terms, conditions, and exclusions of coverage. Coverage may not be available in all jurisdictions.

## **Credit Freeze**

You have the right to put a security freeze, also known as a credit freeze, on your credit file, so that no new credit can be opened in your name without the use of a Personal Identification Number (PIN) that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to access your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. Should you wish to place a credit freeze, please contact all three major consumer reporting agencies listed below.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- 1) Full name, with middle initial and any suffixes;
- 2) Social Security number;
- 3) Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years;
- 5) Proof of current address, such as a current utility bill or telephone bill;
- 6) Other personal information as required by the applicable credit reporting agency.

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

## **Fraud Alerts**

You also have the right to place an initial or extended fraud alert on your file at no cost. An initial fraud alert lasts 1 year and is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.

If you find anything suspicious, call the credit reporting agency at the phone number on the report. Keep a copy of this notice for your records in case of future problems with your records.
