I write in response to your request for public records, received July 26, 2023, in which you requested: *records sufficient to list any and all sworn law enforcement officers at the AGO or any of the of State's Attorneys offices. For each officer, I am looking for at least the following information:*

- Name
- Job title or rank
- Level of certification
- Office or unit affiliation
- Start date at the agency or office
- 2022 salary
- 2022 overtime pay

In response to your request, the Attorney General's Office (AGO) created the attached spreadsheet identifying law enforcement officers employed by the AGO, including job titles, levels of certification, division and unit affiliations, and start dates.
