## NOTICE OF <<SECURITY INCIDENT / DATA BREACH>>

Dear <<Name1>>:

Healix Infusion Therapy, LLC (“Healix”) is writing to make you aware of an event that may affect the security of some of your personal information. Healix provides outpatient infusion services for institutions and physician practices, including <<Data Owner Entity name>>. Safeguarding information is among Healix’s highest priorities, and this letter provides detail about the event, our response to it, and resources available to you to help protect your personal information from possible misuse, should you feel it is appropriate to do so.

**What Happened?** On or about September 12, 2023, Healix became aware of suspicious activity on its network. We immediately took steps to secure our network and launched an investigation to determine the nature and scope of the event. We also retained data privacy counsel and forensic specialists to assist with our investigation. The investigation, which is ongoing, determined an unauthorized actor gained access between September 8 and September 12, 2023, to certain information related to your care at <<Data Owner Entity name>> that was maintained on Healix’s network.

Following this determination, we began an in-depth process to identify the individuals whose information may have been impacted, and reviewed internal Healix records to identify address information for potentially impacted individuals. This process is ongoing. Healix is notifying you out of an abundance of caution because the investigation determined that certain information relating to you may have been accessed or acquired by an unknown unauthorized person.

**What Information Was Involved?** Our investigation determined that certain information related you was contained in Healix’s systems at the time of the event. Unfortunately, we are unable to confirm the specific information related to you but it may include one or more of the following data elements, name, address, driver’s license/state identification number, Social Security number, financial account information, date of birth, medical information (including diagnosis, lab results, medications or other treatment information), and/or health insurance information. Healix is not aware of any attempted or actual misuse of your information.

**What We Are Doing.** Upon becoming aware of this event, we immediately took steps to confirm the security of our network and investigate the full scope of the event. We are also reviewing our existing security policies and implemented additional cybersecurity measures to further protect against similar events moving forward. We have notified federal law enforcement of this event, and the appropriate state and federal regulators.

As an added precaution, as part of this notice, we are providing you with access to <<12/24>> months of credit monitoring and identity theft protection services through Equifax, at no cost you. You can find information on how to enroll in these services in the attached “Steps You Can Take to Help Protect Your Information.” We encourage you to enroll in these services as we are unable to do so on your behalf.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Please also review the information contained in the enclosed “Steps You Can Take to Help Protect Your Information.”

WebScan searches thousands of Internet sites where consumers’ personal information is suspected of being bought and sold, and regularly adds new sites to the list of those it searches. However, the Internet addresses of these suspected Internet trading sites are not published and frequently change, so there is no guarantee that we are able to locate and search every possible Internet site where consumers’ personal information is at risk of being traded.

<sup>3</sup> Locking your Equifax credit report will prevent access to it by certain third parties. Locking your Equifax credit report will not prevent access to your credit report at any other credit reporting agency. ## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

## **Additional Information**

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here.
