Notice of Data [Event/Breach]

Dear Sample A. Sample:

Welltok, Inc., writes on behalf of Cohere Health to inform you of an event that may affect the security of your personal information. Welltok software supports wellness programs offered through Cohere Health and received your information in connection with these services. Although we have no indication of actual fraud or misuse of your information, we are providing you with information about the incident, our response to it, and resources available to you to help protect your information.

What Happened. On July 26, 2023, we became aware of a potential compromise of our MOVEit Transfer server in connection with software vulnerabilities made public by the developer of the MOVEit Transfer tool. MOVEit is a third-party file transfer program we use to exchange and store data to support the services we provide. We had previously installed all published patches and security upgrades immediately upon such patches being made available by Progress Software, the maker of the MOVEit Transfer tool. In addition, we conducted an examination of our systems and networks using all information available to determine any impact of the vulnerability and the security of data housed on the server. At that time, we confirmed there was no indication of any compromise.

Upon being alerted to the potential issue in July, we moved quickly to launch an additional investigation with the assistance of third-party cybersecurity specialists and using additional information that had been discovered in the intervening period, to determine the potential for hidden vulnerabilities on the MOVEit Transfer server. After a full reconstruction of our systems and historical data, we determined on August 11, 2023 that an unknown actor had exploited software vulnerabilities, accessed the MOVEit Transfer server on May 30, 2023, and accessed and removed certain data from the MOVEit Transfer server during that time. We subsequently undertook a time-consuming and detailed reconstruction and review of the data stored on the server at the time of this incident to understand the contents of that data and to whom that data relates. Subsequently, we have learned that data related to you was present on the impacted server at the time of the event.

What Information Was Involved. While we have no evidence that any of your information has been misused, we are notifying you and providing information and resources to help protect your personal information. The following types of information may have been impacted: your name, date of birth, insurance identification number, and address [Extra1].



What We Are Doing. We take this event and the security of personal information in our care very seriously. Upon learning of this event, we moved quickly to investigate and respond to the event and notify potentially affected individuals. As part of our ongoing commitment to the security of information, we are reviewing and enhancing our existing policies and procedures related to data privacy to reduce the likelihood of a similar future event.

What You Can Do. We are making available to you credit monitoring and identity restoration services. We encourage you to enroll in these services. Enrollment information is available in the enclosed *Steps You Can Take to Help Protect Your Information*. While Welltok will cover the cost of these services, you will need to complete the activation process. Welltok, Inc., operates an online contact-management platform that enables healthcare clients to provide patients and members with important notices and communications used by health plans, pharmacies and employers that encourages healthy lifestyle changes. We are writing to inform you of an event that may affect the security of your personal information. Although we have no indication of actual fraud or misuse of your information, we are providing you with information about the incident, our response to it, and resources available to you to help protect your information, should you feel it appropriate to do so.

What Happened. On July 26, 2023, we were alerted to an earlier alleged compromise of our MOVEit Transfer server in connection with software vulnerabilities made public by the developer of the MOVEit Transfer tool. We had previously installed all published patches and security upgrades immediately upon such patches being made available by Progress Software, the maker of the MOVEit Transfer tool and conducted an examination of our systems and networks using all information available to determine the potential impact of the published vulnerabilities' presence on the MOVEit Transfer server and the security of data housed on the server and confirmed that there was no indication of any compromise at that time.

Upon being alerted to the alleged issue, we moved quickly to launch an additional investigation with the assistance of third-party cybersecurity specialists and using additional information that had been discovered in the intervening period, to determine the potential for a hidden presence of vulnerabilities on the MOVEit Transfer server and the security of data housed on the server. After a full reconstruction of our systems and historical data, our investigation determined on August 11, 2023 that an unknown actor exploited software vulnerabilities, accessed the MOVEit Transfer server on May 30, 2023, and exfiltrated certain data from the MOVEit Transfer server during that time. We subsequently undertook a time-consuming and detailed reconstruction and review of the data stored on the server at the time of this incident to understand the contents of that data and to whom that data relates. Subsequently, we have learned that data related to you was present on the impacted server at the time of the event.

What Information Was Involved. While Welltok has no evidence that any information has been misused, the following types of information may have impacted: name, date of birth, telephone number, treatment/ diagnosis information, prescription information, provider name, medical record number, and health insurance information.

What We Are Doing. We take this event and the security of personal information in our care very seriously. Upon learning of this event, we moved quickly to investigate and respond to the event and notify potentially affected individuals. We are writing to inform you of our recent incident at Welltok, Inc. that may affect the security of your personal information. Welltok, Inc. is a wholly owned subsidiary of Virgin Pulse, Inc. and operates a member notification and contact platform. We entered into a contract with West Virginia University Health System (WVUHS) for Camden Clark Medical Center to participate in a pilot program to compile patient and community data and received your information file in connection with these services as part of the agreement. At Welltok, we take the confidentiality of our customers' information very seriously. Notice of Data [Event/ Breach]

Dear Sample A. Sample:

Welltok, Inc., is writing to inform you of an event that may affect the security of your personal information. **Although we have no indication of actual fraud or misuse of your information, we are providing you with information about the incident, our response to it, and resources available to you to help protect your information, should you feel it appropriate to do so.**

What Happened. Welltok is setting up a patient notification and contact platform for ThedaCare and received your information in connection with these services. On July 26, 2023, Welltok was alerted to an alleged compromise of our MOVEit Transfer server that allegedly occurred on May 30, 2023. The compromise was in connection with software vulnerabilities made public by the developer of the MOVEit Transfer tool. Prior to being alerted, we had installed all published patches and security upgrades upon such patches being made available by the maker of the MOVEit Transfer tool and, upon notification, we conducted an examination of our systems and networks, using all information available, and initially confirmed that there was no indication of any compromise at that time.

Given our commitment to protecting personal information, Welltok moved quickly to launch a second investigation with the assistance of a third-party cybersecurity specialist, using additional information that had been discovered in the intervening period. After a full reconstruction of our systems and historical data, our investigation determined on August 11, 2023 that an unknown individual did access the MOVEit Transfer server and exported data. **Subsequently, we learned data related to you was present on the impacted server at the time of the event.**

What Information Was Involved. While we have no evidence that any of your information has been misused and no disruption has occurred to your health care services, we are notifying you and providing information and resources to help protect your personal information. The following types of your information may have been impacted: [Extra1].

What We Are Doing. Protecting customers' data is our top priority, and we take this event and the security of personal information in our care very seriously. Upon learning of this event, we moved quickly to investigate and respond to the event and notify potentially affected individuals. As part of our ongoing commitment to the security of information, we are reviewing and enhancing our existing policies and procedures related to data privacy to prevent a similar future event.



As an added precaution, we are providing you with access to 12 months of credit monitoring and identity protection services provided by Experian. A description of services and instructions on how to enroll can be found within the enclosed Steps You Can Take to Help Protect Your Information. Please note that you must complete the enrollment process yourself, as we are not permitted to enroll you in these services on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by regularly reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You may also review the information contained in the enclosed Steps You Can Take to Help Protect Your Information. There you will also find more information on the credit monitoring and identity restoration services we are making available to you. While Welltok will cover the cost of these services, you will need to complete the activation process. Enrollment instructions are included in this letter.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you may need to provide some or all of the following information:

1. Full name (including middle initial, as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
