Pursuant to Vermont's Public Records Act, 1 V.S.A. §§ 315-320, I am requesting manufacturer submissions and related documents pursuant to Vermont's Prescribed Product Disclosure Law, 18 V.S.A. §§ 4631a.-4632, for the years 2002 through 2016.

#### Background

I understand that beginning in 2002, Vermont required all pharmaceutical manufacturers to annually submit itemized reports of all expenses relating to marketing expenses under the Prescribed Product Disclosure Law, 18 V.S.A. §§ 4631a.-4632. The Vermont Board of Pharmacy collected responses in 2002 and 2003 and submitted these responses to the Attorney General (under Vermont's Pharmaceutical Marketing Disclosure Law, 33 V.S.A. § 005). Beginning in 2004, the Attorney General's Office collected the responses directly from manufacturers. The Attorney General's Office was then required to issue an annual report summarizing the data. The Attorney General's reports and public datasets are available on the Attorney General's Office website.

## **Records Requested**

I request that the Vermont Attorney General's Office produce documents relating to Vermont's Pharmaceutical Marketing Disclosure Law and the Prescribed Product Disclosure Law including, but not limited to:
