#### Dear << Name 1>>:

Citizens Bank of West Virginia values and respects the privacy of your information, which is why we are writing to advise you of an incident that may have involved some of your personal information. Although we are not aware of any instances of fraud or identity theft that have occurred because of this incident, we are contacting you to explain the circumstances of the incident, and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

What Happened? On November 27, 2023, we discovered that an unknown, unauthorized third party accessed our network and encrypted some of our files. Upon learning of the incident, we promptly contained the incident and restored our network from available backups within hours. We also worked with a forensic security firm to investigate and confirm the security of our computer systems. The forensic investigation determined that the unauthorized third party accessed our network through a trusted vendor connection from November 15, 2023, through November 27, 2023, and acquired certain files from our network during that time. This unauthorized access was limited to a portion of our internal network and did not involve unauthorized access to our banking, online banking, or payment systems.

What Information Was Involved? On December 5, 2023, we learned that the unauthorized third party acquired files that contained some individuals' personal information. We reviewed the files that were acquired during the incident, and on February 1, 2024, we determined that the files could have contained your name, <<Breached Elements>>. Please note the files acquired by the unauthorized third party did not contain any online banking log-in credentials or debit card numbers.

What We Are Doing. Citizens Bank has taken great pride in serving many generations of customers in our communities for 100 years. Our relationship with you and the security of your account are our highest priorities. We have taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures and eliminating access to our network by the vendor responsible for this event. We also notified federal law enforcement, and we are cooperating with that investigation. We understand that law enforcement has disrupted the operations of the threat actor group responsible for the incident at Citizens Bank.

Although we are not aware of any instances of fraud or identity theft involving your information, we are providing a complimentary one-year membership of Experian IdentityWorks Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided with this letter.

**Fraud Alerts:** You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. <u>Credit and Security Freezes</u>: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
