Dear Sample A. Sample:

We write to inform you about a matter that may involve your information, our response, and steps you may take should you feel it is appropriate to do so.

**What Happened?** In late-January 2024, we learned that our computer network may have been accessed without permission. In response, we began a review of the matter to determine what occurred and took steps to confirm the security of the network. During our review of this matter, we identified that some files were copied from the network in mid-January 2024. We subsequently undertook a review of the files to identify sensitive information contained therein. We completed our review with respect to your information on March 12, 2024.

**What Information Was Involved?** The information identified in the reviewed files included your name and the following: Social Security number. However, we cannot confirm whether files containing your information were reviewed without permission.

**What We Are Doing.** We are notifying individuals about this matter and providing complimentary identity monitoring services. Additionally, as part of our response to this matter, we implemented supplemental technical security measures and practices to reduce the risk of an event like this occurring.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your relevant account statements and monitoring your free credit reports for suspicious activity and to detect errors. We also recommend you review the “Steps You Can Take To Protect Personal Information” section of this letter. Further, you may enroll in the offered complimentary identity monitoring services. Please note that, due to privacy restrictions, we are unable to automatically enroll you in the complimentary identity monitoring services.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
