# NOTICE OF DATA [Extra1]

Dear Sample A. Sample:

Beaver Run Resort & Conference Center ("Beaver Run") writes to notify you regarding a recent incident that may involve some of your personal information. Although we have no evidence of misuse of your information, we write to provide you with information about the incident, our response, and steps you can take to help protect against the possible misuse of your information, should you feel it is appropriate to do so.

**What Happened.** On February 19, 2024 Beaver Run discovered suspicious activity in its computer network, and determined that certain systems were encrypted and inaccessible. Beaver Run commenced an investigation with the assistance of third-party specialists to determine the nature and scope of the unauthorized activity. Beaver Run also worked to securely restore impacted system operations. The investigation found that an unauthorized actor accessed or acquired certain data between February 6, 2024 and February 19, 2024 stored in the Beaver Run environment. We then worked to review what information could be contained in that data and subsequently determined on April 29, 2024 that it may contain certain personal information related to you.

What Information Was Involved. Your Social Security numbers, driver's license or state identification numbers, passport numbers, financial account information and name may have been present in the data at issue.

What We Are Doing. Beaver Run takes this incident and the security of the information in our care very seriously. Upon discovering the incident, we worked to ensure the security of our environment and worked with third-party cybersecurity specialists to investigate the unauthorized activity to determine what occurred. We have also implemented additional technical safeguards to help prevent similar incidents in the future.

As an added precaution, we are also offering you 24 months of complimentary access to identity monitoring services through Experian. If you wish to receive these services, you must enroll by following the below activation instructions, as we are not able to activate these services on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. Please also review the information contained in the enclosed *Steps You Can Take to Help Protect Your Information*. There you will also find more information on the complimentary identity monitoring services we are making available to you.

#### **Enroll in Monitoring Services**

### **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit <u>www.annualcreditreport.com</u> or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
