I write in response to your Public Records Act request received May 16, 2024, for "all documents relating to any investigation, review, or correspondence regarding the data breach that was announced by loanDepot, Inc. on or about January 4, 2024 (the "Data Breach")...all such documents regarding the Data Breach, including all documents and communications related to the Data Breach, including, but not limited to, any documents or communications with or pertaining to loanDepot and/or its subsidiaries or parent entities by or with the Office of the Vermont Attorney General. This includes, without limitation, 1) all written correspondence with loanDepot concerning the Data Breach; 2) all documents relating to loanDepot's protection, the unauthorized access of, or disclosure of personally identifiable information during or related to the Data Breach, 3) all documents concerning loanDepot's post-Data Breach remedial efforts, including documents and communications with the Office of the Vermont Attorney General regarding notice of the Data Breach, 4) any other documents and communications in your possession relating to the Data Breach, and 5) any documents or information pertaining to any investigation of loanDepot, Inc. and/or its subsidiaries or parent entities since January 1, 2020 to present related to the Data Breach. Please also provide all documents relating to any other separate data breaches or data security incidents involving loanDepot since January 1, 2020."

We are producing the February 23, 2024, notice loanDepot.com sent to our office. We are withholding from production a January 20, 2024, Preliminary Notice sent to our office by loanDepot.com pursuant to the statutory protection from disclosure afforded to preliminary notices under 9 VSA 2435 (b)(3)(B)(iv), but please take note that it does not contain any information that is not present in the February 23, 2024, notice.

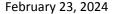

#### **NOTICE OF DATA BREACH**

#### Dear Sample A. Sample,

We are writing to inform you of a data security incident in which your sensitive personal information may have been accessed by an unauthorized third party. This notice provides information concerning the incident and the services we are offering at no charge to help you protect yourself.

#### What Happened?

On or about January 4, 2024, loanDepot identified a potential incident affecting its systems.
