I write in response to your Public Records Act request submitted on May 20, 2024, seeking: "Lawsuit between the state of VT and 7 unnamed youth regarding the Woodside juvenile rehab center, which resulted in a \$4.5 million settlement."

During our telephone conversation on May 20, 2024, you clarified you were seeking all the documents filed in the federal lawsuit, *Estate of G.W.*, et al. v. Schatz, et al., Docket No. 21-cv-283 (D.Vt.), as well as the settlement agreement and releases executed at the conclusion of that lawsuit, which were not filed with the federal court. The releases reflect redactions of personally-identifying information of the minor parties pursuant to 1 V.S.A. § 317(c)(1) and (7).
