Pursuant to Vermont's Public Records Laws (*see e.g.*, 1 V.S.A. §§ 315-320), I am requesting copies of the following from the Vermont Office of the Attorney General ("AGO"), with the relevant dates for the following request being 01/01/1978 through 05/24/2024:

1. Any and all documents related to Dr. Richard DeGrandchamp's ("Dr. DeGrandchamp") toxicological, risk assessment, and/or technical expertise for his work for/with the AGO.
