Dear Mr. Bradley:

I write in response to your Public Records Act request dated June 6, 2024, in which you requested:

the total cost of defending the State against [the current federal lawsuit brought by the Vermont Federation of Sportsmen's Clubs challenging the constitutionality of 13 V.S.A. § 4019a and 13 V.S.A. § 4021], starting from 7/1/2023, including the cost of time spent by state employees, costs associated with outside legal firms / consultants, costs associated with hired experts; in short, all costs related to this defense to date.

On June 11, 2024, I notified you that the Attorney General's Office ("AGO") would need to invoke a 10-day extension to respond to your request, consistent with 1 V.S.A. § 318(b)(5).

We have completed our analysis of your request and have not identified any records that would be subject to disclosure. First, insofar as your request seeks information rather than records, it is not an appropriate request under the Vermont Public Records Act. Second, to the extent your request seeks existing documents or other records reflecting the requested information, those documents would be exempt from disclosure under 1 V.S.A. § 317(c)(14), exempting records that are "relevant to litigation" within the meaning of that section. *See Wesco, Inc. v. Sorrell*, 2004 VT 102, ¶¶ 16-17 (exemption covers all documents that are "related to" or "pertinent to" ongoing litigation against public agency, whether documents are discoverable in that litigation or not).
