Coastal Orthopedics ("Coastal") is writing to notify you of an incident that may affect the privacy of some of your information. Although we have no evidence of any identity theft or fraud occurring as a result of this event, this letter provides details of the incident, our response, and resources available to you to help protect your information, should you feel it appropriate to do so.

What Happened? On or around June 11, 2023, Coastal became aware of suspicious activity affecting certain systems within our network. We immediately launched an investigation to determine the nature and scope of the activity. The investigation determined there was unauthorized access to our network between June 6, 2023 and June 11, 2023, and that certain files and folders within our network were taken without authorization during that time. Therefore, out of an abundance of caution, Coastal, with the assistance of third-party specialists, conducted a comprehensive and time-intensive review of the contents of the files to determine whether sensitive information was involved. Coastal also engaged in a detailed review of its internal records to attempt to locate last known address information for individuals, and to validate the available address information. This process completed on June 10, 2024.

What Information Was Involved? Our review determined the following types of information related to you were involved in this incident: your name, <<Data Elements>>. At this time, we have no indication that your information was used to commit identity theft or fraud as a result of this incident.

What We Are Doing. We take this incident and the security of information in our care very seriously. Upon becoming aware of this incident, we promptly commenced an investigation to determine the nature and scope of this incident. This investigation and response included, but was not limited to, assessing the security of our systems, reviewing the contents of relevant data for sensitive information, and notifying impacted individuals for whom we had contact information. As part of our ongoing commitment to the privacy of information in our care, we are re-reviewing our policies, procedures and processes to see if we can further reduce the likelihood of a similar future event. We will also notify, or have notified, applicable regulatory authorities where necessary.

As an added precaution, we are also offering <<CM Duration>> months of complimentary access to credit monitoring services through CyEx, a reputable credit monitoring service. Individuals who wish to receive these services must enroll by following the attached enrollment instructions as we are not able to enroll you on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months. You may also review the information contained in the attached Steps You Can Take to Help Protect Personal Information. There you will also find more information on the complimentary credit monitoring services we are making available to you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission may be reached at: 600 Pennsylvania Avenue NW, Washington, D.C. 20580; www.identitytheft.gov; 1-877-ID-THEFT (1-877-438-4338); and TTY: 1-866-653-4261. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim.
