Dear Chris LoMonaco,

I write in response to your Public Records Act request dated Friday, July 19, 2024, and received by our office on Monday, July 22, 2024, a copy of which is attached for your convenience. I respond now with a cost estimate following a 10-day extension.

For documents concerning consumer complaints against “Greensky, LLC”, we estimate that searching for (80 minutes accrued), reviewing, and redacting the files (9 complaints amounting to 96 files) will come to approximately 1050 minutes. Note that there is no charge for the first 30 minutes. At 1020 minutes, billed at the lowest possible rate under the Secretary of State's fee schedule for the rate of other staff time (\$.54 a minute), the cost of your Public Records Act request is an estimated \$459.00.

We ask that you confirm your willingness to pay the estimated cost before we proceed further with processing your request. Upon receipt of your payment, the records will be made available for you. Note, if the actual time to produce the records is less, a credit will be issued to you.
