- 1 V.S.A. § 317(c)(3) Records which, if made public pursuant to the PRA, would cause the custodian to violate duly adopted standards of ethics or conduct for any profession regulated by the State. Please see Rule 3.8 (Special Responsibilities of a Prosecutor) of the Vermont Rules of Professional Conduct.
- 1 V.S.A. § 317(c)(5)(A)(iii) Records dealing with the detection and investigation of crime that could reasonably be expected to constitute an unwarranted invasion of personal privacy.
- 1 V.S.A. § 317(c)(5)(D) Records dealing with the detection and investigation of crime that could reveal information that could be used to facilitate the commission of a crime or the identity of a private individual who is a witness to or victim of a crime.

## Springfield Resident Arrested for Attempted Luring of a Child

MONTPELIER, Vt. – The Attorney General's Office announced that James Beam, 29, of Springfield, Vermont, was arraigned today on one felony count of Attempted Luring of a Child. The charge brought against Mr. Beam is the result of an undercover criminal investigation conducted by the Hartford Police Department and the Vermont Internet Crimes Against Children Task Force (VT-ICAC) during which Mr. Beam initiated contact online via the Grindr application with a Hartford investigator posing as a 14-year-old minor. Mr. Beam engaged in sexual conversations with the undercover investigator and set up a meeting to engage in sexual acts.

Mr. Beam pleaded not guilty at the arraignment today in Vermont Superior Court, Windsor Criminal Division. The Court, Judge Heather Gray presiding, ordered conditions of release that restricts Mr. Beam's contact with minors and access to the internet.

VT-ICAC investigates cases of child sexual exploitation occurring over the internet, including the production and online distribution of child sexual abuse materials. VT-ICAC also provides forensic examination services, technical assistance, law enforcement training, and public education and outreach.

Every child deserves a safe childhood. The National Center for Missing and Exploited Children (NCMEC) is the nation's centralized reporting system for the online exploitation of children. Anyone can make reports of suspected online enticement of children for sexual acts, child sexual molestation, child sexual abuse material, child sex tourism, child sex trafficking, unsolicited obscene materials sent to a child, misleading domain names, and misleading words or digital images on the internet. Additionally, if you are recovering from child sexual exploitation, you do not have to navigate it alone.
