Dear Mr. Jacobson,

On behalf of the Vermont Attorney General's Office (AGO) Consumer Protection Unit (CPU), we are writing in response to the public request you submitted through the AGO's website on November 6, 2024. You requested:

[A]ll records pertaining to the not-for-profit GODDARD COLLEGE and EXECUSUITE, and/or MIKE DAVIDSON of Lebanon, N.H, dated from the period beginning June 1, 2024 through to November 7, 2024. I am requesting any email correspondence, any letters or any documents pertaining to GODDARD COLLEGE, to the dissolution and sale of its assets; any email, letters or documents from or to Goddard College in the period beginning June 1, 2024 to November 7, 202 4; I am requesting a copy of any correspondence by email, letters or any documents pertaining to "Execusuite" of Lebanon, N.H, as well as any correspondence by email, any letters or any documents that pertain to Mike Davidson of Execusuite of Lebanon, N.H, for the period beginning June 1, 2024 to November 7, 2024.

Your request is governed by Vermont's Public Records Act (PRA), 1 V.S.A. §§ 315-320.

The AGO requires an extension of time, not to exceed 10 business days from the time you submitted your request on November 6, 2024, so that we may have sufficient time to review our files to identify and make available any responsive records subject to PRA inspection and copying. See 1 V.S.A. § 318(b)(5). Accordingly, we will respond to your request by November 22, 2024.

We note that in responding to similar, previous requests from other requestors, the AGO has already published on our website some documents relevant to your request. While we are reviewing our records for any responsive records that have not yet been published, we encourage you to consult our website in the meantime.

We will follow up when we have completed our review.
