RE: NOTICE OF DATA BREACH

Dear Sample A. Sample,

Bamboo Rose takes the privacy and security of personal information seriously. As such, we are writing to inform you of a cybersecurity incident that we recently experienced and which may have impacted some of your information. This letter is to inform you of the incident, the steps we are taking in response, and the steps that you may consider to help protect your information.

What Happened? On September 27, 2024, we discovered that an unauthorized party gained access to Bamboo Rose’s non-production environment. Bamboo Rose immediately implemented steps to contain the incident, including proactively taking systems offline, and launched an investigation to determine the nature and scope of the incident with assistance from third-party experts. Bamboo Rose also notified law enforcement and continues to support their investigation. Bamboo Rose remains fully operational and did not experience any disruptions to production systems and operations.

The investigation found that an unauthorized actor accessed certain Bamboo Rose systems and obtained certain files between September 20, 2024 and September 27, 2024. Bamboo Rose then began conducting a review of the files to identify individuals whose personal information may have been contained in the files.

What Information Was Involved? On October 13, 2024, we determined that some of your personal information may have been contained in the files, which may include your name, Social Security number, date of birth, address, and/or bank account information.

What We Are Doing? To help prevent a similar incident from occurring in the future, Bamboo Rose has implemented, and continues to evaluate and implement, additional measures to enhance the security of its systems and data.

At this time, we have no evidence that any of your personal information has been misused for purposes of fraud or identity theft, and we have taken steps to help mitigate such risks. As a precaution, we are offering you a complimentary 24-month membership of Experian’s® IdentityWorksSM at no cost to you. This product provides you with superior identity protection and resolution of identity theft. IdentityWorksSM Credit 1B is completely free to you and enrolling in this program will not hurt your credit score.



What You Can Do? We encourage you to review the additional information on Experian IdentityWorksSM, including instructions on activating your complimentary 24-month membership, as well as the additional information on steps you can take in response to this incident on the pages that follow this letter.

Free Credit Report. We remind you to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. If you identify any unauthorized charges on your financial account statements, you should immediately report any such charges to your financial institution. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. To order your annual free credit report, please visit www.annualcreditreport.com or call toll free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available from the U.S. Federal Trade Commission's ("FTC") website at www.consumer.ftc.gov) to: Annual Credit Report Request Service, P.O. For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents:

You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Security Freeze. Security freezes, also known as credit freezes, restrict access to your credit file, making it harder for identity thieves to open new accounts in your name. You can freeze and unfreeze your credit file for free. You also can get a free freeze for your children who are under 16. And if you are someone's guardian, conservator or have a valid power of attorney, you can get a free freeze for that person, too.

How will these freezes work? Contact all three of the nationwide credit reporting agencies – Equifax, Experian, and TransUnion. If you request a freeze online or by phone, the agency must place the freeze within one business day. If you request a lift of the freeze, the agency must lift it within one hour. If you make your request by mail, the agency must place or lift the freeze within three business days after it gets your request. You also can lift the freeze temporarily without a fee.

The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement.

It is essential that each copy be legible, display your name and current mailing address, and the date of issue.

For New Mexico residents: You may obtain a security freeze on your credit report to protect your privacy and ensure that credit is not granted in your name without your knowledge. You may submit a declaration of removal to remove information placed in your credit report as a result of being a victim of identity theft. You have a right to place a security freeze on your credit report or submit a declaration of removal pursuant

Fraud Alerts. A fraud alert tells businesses that check your credit that they should check with you before opening a new account. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

Federal Trade Commission and State Attorneys General Offices. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft.
