On behalf of the Vermont Attorney General's Office (AGO) Consumer Protection Unit (CPU), we are writing in response to the public request you submitted through the AGO's website on November 20, 2024. You requested:

I am writing in response to on files sent by the Office of the Attorney General to Eric Jacobson on November 19, 2024, in fulfilment of a Public Records Request. Included in these files was a document titled "UPDATE TO 11B V.S.A. §12.02(g) NOTICE November 12, 2024." This document, in paragraph 3, states that Goddard College will use the \$1.6 million initial payment from Execusuite LLC for "payment of all of Goddard's financial obligations." I would like to receive any filings, documents, or correspondence by or from Goddard College, between the dates of June 1, 2024, and November 20, 2024, that demonstrate or itemize these financial obligations, for the satisfaction of which it is pursuing the sale of for-profit its campus entity. Thank you.

Your request is governed by Vermont's Public Records Act (PRA), 1 V.S.A. §§ 315-320.

The AGO requires an extension of time, not to exceed 10 business days from the time you submitted your request on November 20, 2024, so that we may have sufficient time to review our files to identify and make available any responsive records subject to PRA inspection and copying. *See* 1 V.S.A. § 318(b)(5). Accordingly, we will respond to your request by December 6, 2024.

We note that in responding to similar, previous requests from other requestors, the AGO has already published on our website some documents relevant to your request. While we are reviewing our records for any responsive records that have not yet been published, we encourage you to consult our website in the meantime.

We will follow up when we have completed our review.
