Thank you for the initial responses, they are much appreciated.

After reviewing the responses, I'd like to resubmit my initial request for:

- Copies of all communications dating from January 01, 2008 to present, between – to and from – employees or representatives of the Office of the Attorney General of Vermont and the Federal Trade Commission related to gasoline prices.
- Copies of all communications dating from January 01, 2008 to present, between – to and from – the Office of the Attorney General of Vermont and all employees or representatives of the Office of U.S. Senator Bernard Sanders related to gasoline prices in the greater Burlington, Vermont area (Chittenden, Grand Isle and Franklin Counties).
- Copies of all consumer complaints sent to the Office of the Attorney General of Vermont's Consumer Protection Unit dating from January 01, 2008 to present, 2013 related to gasoline prices in the greater Burlington, Vermont area (Chittenden, Grand Isle and Franklin Counties).

As you will recall, our initial request was amended – per our agreement on February 1 – to cover a period of October 2013 to present. Since the responses transmitted to our office on February 17 are responsive to that narrower scope, additional responses only need to satisfy the period between January 1, 2008 to October 31, 2013.
