Thank you for your patience as we compile the records related to your request. The materials which are covered by the request are voluminous and may contain records which will require redaction and others which may be exempt from disclosure pursuant to provisions contained within 1 V.S.A. § 317. There are approximately 477 pages of records as well as several hours of video and audio recording that cover your request.
