I write in response to your February 12 email again requesting that the revised cost estimate provided by our office be decreased. The estimate we provided you remains consistent with the Uniform Schedule of Public Records Charges for State Agencies. In this case, as with all requests, we are obliged to consider the commitment of Staff and Senior Staff resources in meeting requests. We are also obliged to be consistent in responding to all requests. Accordingly, we are unable to amend the revised estimate.
