Dear Mark Davis:

We wanted to inform you of changes to the cost estimate we provided you on January 30 to your Public Records Act request.

As you may be aware, Max Misch was arraigned on criminal charges which are currently pending. Consistent with 1 V.S.A. § 317(c)(5)(A)(ii), because the documentation you requested contains some information that could deprive Max Misch of his right to a fair trial, we are obliged, at this stage, to exempt this information from disclosure. Additionally, there may be information that is exempt under 1 V.S.A. § 317(c)(5)(A)(iii) because the information could constitute an unwarranted invasion of personal privacy. Finally, there may also be information that is exempt under 1 V.S.A. § 317(c)(3) because disclosure would violate duly adopted Vermont Rules of Professional Conduct.

The material available for disclosure now includes approximately 217 pages of electronic records. The revised cost estimate:
