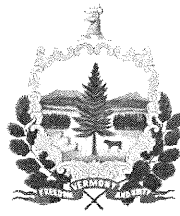


1. Attorney review of records	20 hrs @ \$.57/min
2. Attorney redaction of paper records	10 hrs @ \$.57/min
3. Attorney redaction of audio records	8 hrs @ \$.57/min
4. Attorney redaction of video records	8 hrs @ \$.57/min
5. Admin redaction of paper records	3 hrs @ \$.33/min
6. Admin redaction of audio records	27 hrs @ \$.33/min
7. Admin redaction of video records	12 hrs @ \$.33/min
8. Admin scanning of paper records	5 hrs @ \$.33/min
9. Admin copying of audio records	TBD
10. Admin copying of video records	TBD
11. Paper/CD/DVD materials	TBD
