Dear Guy:

Attached please find records responsive to your Vermont Public Records Act request, dated December 11, 2019. The text of your request was:

“Please give me 2019 public records on State of Vermont funding of Planned Parenthood to replace federal Title X funding lost under Trump administration decision this year.”

After providing you with a cost estimate, we received your payment of \$188.80 on February 7, 2020. As I mentioned on the phone, the cost estimate was over-inclusive and the number of records actually responsive to your records is smaller than initially estimated. If you wish to make a new request that is less narrow, please let me know.

The time it took to gather, review, analyze, and redact these documents was less than 30 minutes, and, therefore, these documents are provided with no cost to you. A refund check for the full amount of \$188.80 will be issued to you.

You will see that the attached responsive records have been redacted. These redactions are due to portions of the documents being exempt from the Public Records Act pursuant to 1 V.S.A. § 317(c)(3) and (4). If you feel portions of our response have been withheld in error, you may

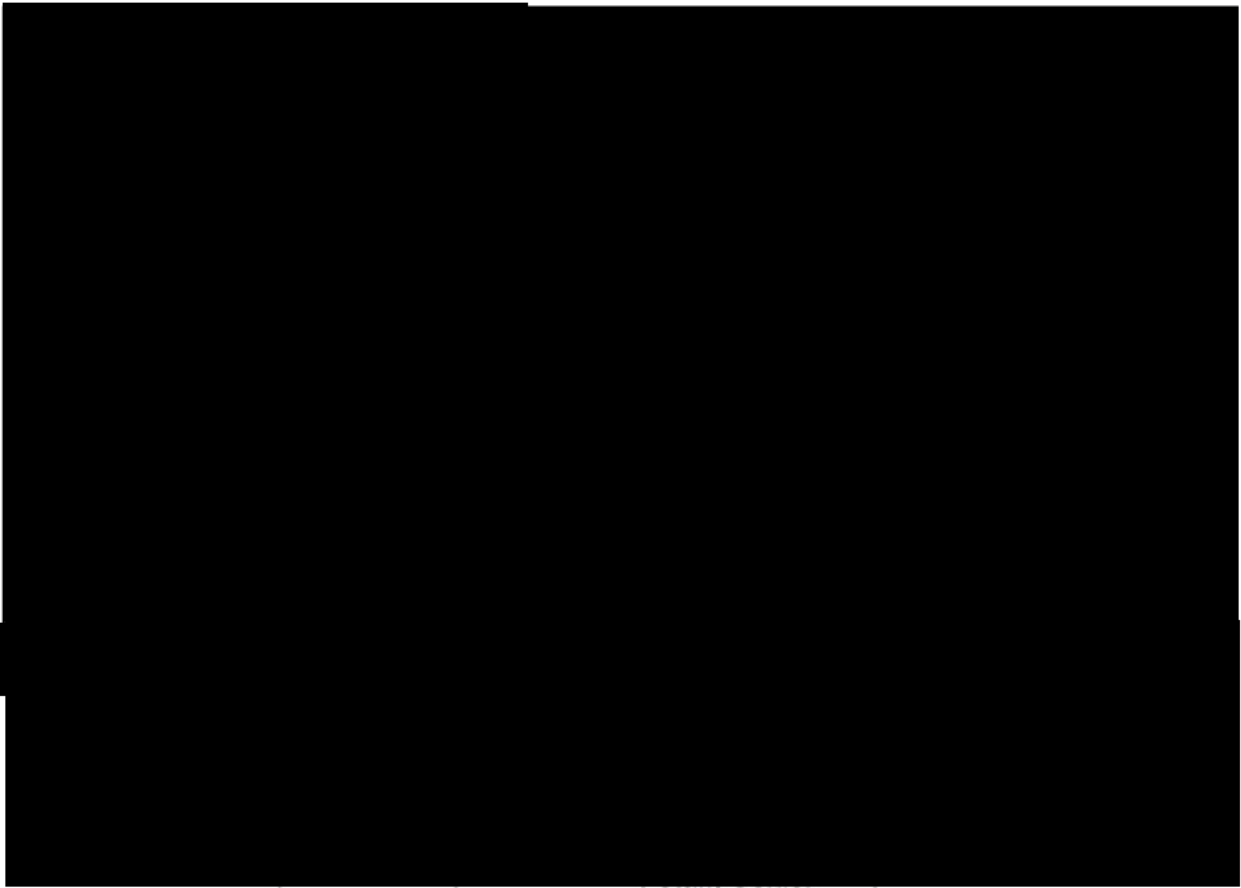
