
If possible, we would appreciate you producing responsive documents as multi-page TIFF or PDF files or as single-page TIFF or PDF files with accompanying load files for e-discovery software that includes metadata fields identifying natural document breaks. Please preserve and produce all metadata including: (a) the author(s) of the electronically stored information ("ESI"), (b) the recipient(s) of the ESI, (c) the date the ESI was created, and (d) the source from which the ESI was produced. The "source" of the ESI shall be the name of the person who was the custodian of the ESI or, if the name of a person is not available, the storage location.

If you withhold or redact any documents that are responsive to these requests, please produce a privilege log containing the following information: (a) document date, (b) document author(s) or creator(s), (c) recipient(s), (d) description of subject or content, (e) the source from which the ESI was produced, and (f) the statute or rule under whose authority you have withheld the document.
