2) Has R1 RCM Inc been investigated in the recent past by your office (Jan 1 2018 to present), and if so were there any enforcement actions taken against the company? Are documents available describing the findings of the investigation and enforcement actions taken by you at its conclusion. If possible I would like to obtain electronic copies of any such documents.

3) Have any complaints against R1 RCM Inc been filed with your office or with your division of consumer protection since January 1 2018? How many such complaints in each of 2018, 2019, 2020, and 2021 year-to-date? If possible I would like to obtain electronic copies of any such complaints.
