Dear Sir/Madam,

This is my second request for all records in the case #2012-92-07659.

I am requesting all police records, crime scene photos and video, ballistic reports, forensic results, phone records and obtained search warrants in the investigation into the deaths of Jennifer Murphy and Kirin Hammer, in Newfane, VT on August 11, 1992.

Also requested are the police logs, for both the Brattleboro Police Department and Vermont State Police. Specifically requested are the logs for Brattleboro police Lt. Det. Steven Rowell and Lt. Det. Glenn Cutting as well as Vermont State Police Lt. William Pettingill, Vermont State Police Lt. Clint Gray, and Vermont State Police Sgt. Terrance Martin for the length of time for the entire investigation.

In addition, please include the initial 'missing persons report' of Jennifer Murphy made by Warren Murphy on August 11 and August 12, 1992, headed by Lt. Det. Steven Rowell of the Brattleboro police department. Please also include any/all police-related notes and documentation on the deaths, search and recovery of both Jennifer Murphy and Kirin P. Hammer. Also requested, are communications between the Fish and Game warden, Robert Bingham and the Brattleboro police department, on August 11th, 1992, especially after 7:30pm.

Lastly, this request includes the record of any 911 calls made to the Brattleboro police station and Vermont State Police on August 11th 1992. Especially at 7:30pm, made by a "Newfane resident," as well as by Warren Murphy, to Brattleboro police at 10:30pm both Tuesday August 11th, 1992, and again the next morning at 11am, Wednesday, August 12th, 1992. If any of the above does not exist, please so state.
