To Whom It May Concern:

Under the Vermont Public Records Law, §315 et seq., we request to obtain copies of the following documents:

- The Breach Notification submitted by Smile Brands, Inc. for the Breach discovered on or around April 24, 2021, reporting a "Notice of Data Breach" of "names, addresses, telephone numbers, Social Security numbers, dates of birth, health insurance information, and/or diagnosis information";
- Any attachments, addenda, exhibits, or supplements to the Breach Notification;
- Any communications between the Office of the Attorney General and any of its attorneys or investigators or employees Smile Brands, Inc. or its representatives, agents or attorneys;
- Any documents created or obtained by the Office of the Attorney General in its investigation of the data breach reported publicly Smile Brands, Inc. on or around April 24, 2021, including any investigation reports, interview reports, summaries, evidentiary records, notes, memoranda, letters, emails, or other records.

This is a commercial request. If there are any fees charged for searching, reviewing, or copying the records, please supply the records without informing us of the cost if the fees do not exceed \$200.00, which we agree to pay. If the fees exceed this amount, please let us know prior to fulfilling our request.

The law requires a response to this request within 2 days, or within 10 days for extraordinary circumstances. If you expect a significant delay in fulfilling this request, please contact me with information about when I might expect copies or the ability to inspect the requested records.


