1. "Average Length of Stay" of a violation: Normally, I am used to seeing lack residency affect an inmate's release date, and "average length of stay" accordingly.

Violations, specifically due to relapse or lack of residency would

help even more. Annually, (by calendar year) would be great. Median would work, but I prefer to eliminate outliers myself. Mean may be deceptive with incomplete data.

2. "Number of violations of conditions/probation per year"

Again, violations specifically due to relapse or lack of residency would help even more.

3. Funding allocated/spent to house inmates in recovery homes and maintain residency.

This Stat is normally represented by checks up to \$1,000 from probation and parole for an original payment to a recovery home, or if the client (offender) gets behind and needs "rent" for a couple weeks.
