Dear Mr. Blutstein:

We have received your request made pursuant to Vermont's Public Records Act, 1 V.S.A §§ 315-320, and dated May 6, 2022. You asked for the "employment application and resume of Rory Thibault" and for Attorney General Office records "indicating Mr. Thibault's salary."

Mr. Thibault's job application and resume provided to the AGO as part of his job application are exempt from public disclosure pursuant to 1 V.S.A. § 317(c)(7) and are therefore withheld. This is consistent with State of Vermont Personnel Policy 5.4 regarding Personnel Records available at:

https://humanresources.vermont.gov/sites/humanresources/files/documents/Labor_Relations_Policy_EEO/Policy_Procedure_Manual/Number_5.4_PERSONNEL_RECORDS.pdf.

As you know from prior correspondence, salaries for Vermont state employees are online at: <https://data.vermont.gov/widgets/jgqy-2smf>. The AGO is not the custodian of employee salary histories. As a courtesy, our understanding is that Mr. Thibault's salary as an Assistant Attorney General in the fall of 2017 was \$75,004.80. To the extent you seek official information related to Mr. Thibault's salary history, we recommend you contact the Vermont Department of Human Resources at: <https://humanresources.vermont.gov/data/public-records>.

If you feel records have been withheld in error, you may appeal to Deputy Attorney General Joshua Diamond.
