Please be advised that we have been assigned to represent and protect the interests of FedEx Ground Package System, Inc. in a pending legal action. This action arises out of the motor vehicle accident which occurred on June 6, 2022. The accident location is 155 North River Street, Swanton, VT, 05488. It is our understanding that the Vermont State Police Department responded to this accident and that officers were at the scene on June 22, 2022.
