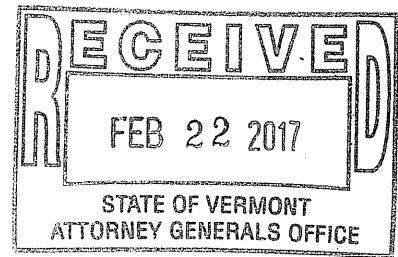




Pursuant to 5 USC § 552(a)(6)(A)(i), I request that you make a determination regarding the release of this information within the 20 day statutory period.

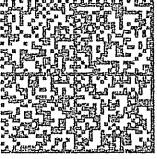
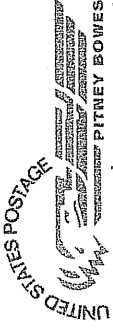
