Dear Mr. Yerardi-

I write in follow up to our communications of earlier this week, and in response to your amended public record act request dated January 12, 2018. This email serves to provide you with additional information regarding the costs associated with your request. We ask that you to confirm your willingness to pay associated costs before we proceed with processing your request.

Your amended request asks us to query our office databases to report the number of employment discrimination complaints received by the Civil Rights Unit of the Vermont Attorney General's Office that did not lead to charges of employment discrimination, for each year as far back as the databases can report this information. In order to complete this request, we will need to run database queries and then manually compare records of files opened with records of charges issued. Records from older, legacy databases may not be complete, and we would identify limitations in the data in our response to you.

We estimate that this task will take us approximately 5-6 hours to complete. Subtracting the first 30 minutes and using the lowest possible rate available under the Secretary of State's public record fee schedule (\$.33 a minute), costs of providing you the information you seek are likely to be around \$89.10- \$108.90. If you are willing to pay initial costs quoted above, please let us know and we will proceed with seeking to fulfill your request within the next week.
