"1) For the period of July 30, 2018, to the present, records and information containing or about any of the following subjects: CodeIsFreeSpeech.com; Firearms Policy Coalition; FPC; Firearms Policy Foundation; FPF; The Calguns Foundation; CGF; California Association of Federal Firearms Licensees; CAL-FFL; Brandon Combs; Gene Hoffman. 2) For the period of July 30, 2018, to the present, records and information that are or refer to communications with Amazon AWS or Amazon Web Services (including but not limited to communications to or from ec2-abuse@amazon.com) about CodeIsFreeSpeech.com, the subject "Liberator," or the subject "liberator_complete.zip." 3) For the period of July 30, 2018, to the present, all records and information containing or about any of the following subjects: Defense Distributed; ghostgunner.net; Shopify; Ghost Gunner; Ghost Gunner 2; CNC; 80% lower."

Pursuant to 1 V.S.A. § 318(a)(5), the Attorney General's Office will need to invoke its right to additional time respond to your request due to the need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records which are demanded in a single request. We will further respond within ten business days of receipt of your request.
