Maine Maritime Academy (“Maine Maritime”) writes to notify you of an incident that may affect the security of some of your personal information. We want to provide you with information about the incident, our response and steps you may take to better protect against possible misuse of your personal information, should you feel it appropriate to do so.

**What happened?** On October 31, 2018, Maine Maritime was alerted to suspicious activity related to certain Maine Maritime email accounts. Maine Maritime immediately launched an investigation to determine the nature and scope of this incident. Through its detailed and exhaustive investigation, Maine Maritime determined that there was unauthorized access to certain Maine Maritime email accounts as a result of a phishing attack. The unauthorized access occurred between September 18, 2018 and December 10, 2018. The email credentials were changed, and the email accounts have been secured. A leading forensic investigation firm was immediately retained to assist with the investigation into what happened and what information contained within the email accounts may be affected.

The contents of the accounts were reviewed through an exhaustive programmatic and manual review process to determine what sensitive information may have been accessible. On March 12, 2019, we confirmed the identities of the individuals who may have had information contained in the email accounts and promptly launched a review of our files to ascertain address information for the impacted individuals to provide notice of this incident.

**What Information was Involved?** While we have no evidence that your information was subject to actual or attempted misuse, we confirmed that your <<ClientDef1(name, address [, / and][variable text])>><<ClientDef2([variable text])>> were contained within the affected email accounts.

**What We Are Doing.** The confidentiality, privacy, and security of our sensitive information is one of our highest priorities. Upon learning of the event, we immediately commenced an investigation to confirm the nature and scope of the incident and to identify what information may be present in the affected email accounts. While we have measures in place to protect information in our systems, we are reviewing our existing policies and procedures for ways to continue improving existing security.

As an added precaution, we are offering you access to 1 year of credit monitoring and identity theft restoration services through Kroll at no cost to you. Please review the attached “Steps You Can Take to Protect Your Information” for information on these services and instruction on how to enroll. We encourage you to enroll in these services as we are not able to act on your behalf to do so.

**What You Can Do.** Please review the enclosed “Steps You Can Take to Protect Your Information,” which contains information on what you can do to better protect against possible misuse of your information. You may also enroll in the credit monitoring and identity theft restoration services we are offering, as we are unable to do so on your behalf.

## **STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION**

To help relieve concerns and restore confidence following this incident, we have secured the services of Kroll to provide identity monitoring at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

### **Monitor Your Accounts**

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity and to detect error over the next 12 to 24 months. Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

You have the right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a security freeze on your credit report. In order to request a security freeze, you will need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, military identification, etc.);
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

As an alternative to a security freeze, you have the right to place an initial or extended "fraud alert" on your file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. ## **Additional Information**

You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General.

**For New Mexico residents**, you have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in your credit file has been used against you, the right to know what is in your credit file, the right to ask for your credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from violator. You may have additional rights under the Fair Credit Reporting Act not summarized here. You've been provided with access to the following services<sup>1</sup> from Kroll:
