Dear Ms. Brown:

I am writing to follow up on your July 24, 2020 e-mail message in which you requested (1) inspection or (2) copies of “records regarding the group ‘Patriot Front’ in the bias reporting database.” In a follow up conversation with Assistant Attorney General Emily Adams on July 28, 2020, you clarified that your request was for any files or records the Office of the Attorney General maintained relating to “Patriot Front.” Between July 31 and August 4, you corresponded with our office regarding the estimated cost involved with collecting, reviewing, and potentially redacting responsive records. We have received that payment and completed our review.

This request is governed by Vermont’s Public Records Act, 1 V.S.A. §§ 315-320.

I. Records Produced; Redactions.

Enclosed with this letter are 36 pages of non-exempt records responsive to your request. The documents stamped AGO-001 to AGO-036, include reports to the Attorney General’s Office (AGO), its Civil Rights Unit (Unit), and other agencies regarding Patriot Front activity in Vermont.

You will note that several of the records provided include redacted material. The redacted information consists of personally identifiable information, such as the names or contact information of witnesses or complainants. Such information is exempt from disclosure pursuant to [1 V.S.A. § 317\(c\)\(5\)\(iv-vi\)](#).

II. Records Not Produced.

A. Internal CRU Correspondence and Notes.

The CRU did not produce any CRU investigator notes or internal CRU or AGO communications or documents. Such materials are confidential work product and subject to the attorney-client privilege. Thus, they are exempt from public disclosure. See [1 V.S.A. § 317\(c\)\(1-4\)](#).

B. Confidential Communications with Vermont State Police.

Similarly, the CRU did not produce any records reflecting confidential communications with the Vermont State Police (VSP). Because the AGO and its CRU serve as legal counsel to the State of Vermont (including its government agencies or departments), such records constitute confidential work product and attorney-client privileged communications. Thus, they are exempt from public disclosure pursuant to [1 V.S.A. § 317\(c\)\(1-4\)](#).

Some of these materials also include records that are *also* exempt from disclosure for the reasons set forth in Section II.C. below.

C. Confidential Records Relating to Criminal Investigations.

Finally, the CRU did not produce records relating to any open criminal investigations relating to Patriot Front. Such records are exempt from production pursuant to [1 V.S.A. § 317\(c\)\(5\)\(A\)](#).

To the extent that this constitutes a denial of your request, you can submit a written appeal of this decision to:



> I have unfortunately received this information. I'm not sure who to tell but I'm reaching out to share because I find it upsetting and terrifying. There's a general distrust of the police from the community that informed me because the police didn't respond right away - A and B - there's a belief that there's been no effective way of identifying and weeding out white supremacists from the police. Also, there's a fear of media because there's the belief that boosting the message of the neonazi whatever is exactly what they want - so reporting on it would in effect - spread the word. I can't hold this information by myself and you may already know about this. I'd like to know if someone tells me again this is happening, what the best protocol is.

> I wanted to let you folks know about white supremacist propaganda found in Burlington. We tore down about 30 of these on Riverside Ave. yesterday (near Koffee Kup and Cumberland Farms.) I'll attach some photos. BPD was informed, but never called back-- we are currently not pursuing police action because it would likely do more harm than good to the community in the form of increased policing, give unwanted attention to the white supremacists, or allow the police to control the narrative. Haven't gone to any news media with it yet either for the same reasons. Feel free to pass this along to allies or give them my contact info if folks have questions-- no idea who posted the stickers, but they are for the "Patriot Front."
