Re: Notice of Data breach

Dear Sample A Sample:

New York City Ballet, Inc. ("NYCB") recently concluded an investigation involving unauthorized access to a NYCB employee's email account. On or about April 1, 2020, NYCB became aware of suspicious activity and immediately changed the email account user's password and began working with outside cybersecurity specialists to investigate the nature and scope of the activity. The investigation determined that the employee email account was accessed by an unknown individual on April 1, 2020 for a brief period of time. However, the investigation was unable to determine whether any information contained in email messages or file attachments stored within the account had been actually viewed or accessed by that individual. In an abundance of caution, NYCB, working with a third-party vendor, undertook a thorough review of the contents of the email account. On June 2, 2020, NYCB received the results of this review and began analyzing internal records to determine the identities of the individuals whose personal information was contained within the account.

On July 22, 2020, NYCB completed its internal review and confirmed that your name and Data Elements were contained within the email account. At this time, NYCB is unaware of any actual or attempted misuse of your personal information in relation to this incident.

The security of personal information within our care is among our highest priorities. Upon learning of the event, we investigated to determine the nature and scope of the activity, and secured the email account.

As an added precaution, NYCB is offering you access to 24 months of free credit monitoring and identity protection services through Experian at no cost to you. Details of this offer and instructions on how to enroll in the services are enclosed within this letter. Please review the enclosed *Steps You Can Take to Protect Against Identity Theft and Fraud*, which contains information on what you can do to protect against possible misuse of your information.

Steps You Can Take to Protect Against Identity Theft and Fraud

Enroll in Identity Monitoring

To help protect your identity, we are offering a complimentary two-year membership of Experian's® IdentityWorksSM. This product provides you with superior identity detection and resolution of identity theft. To activate your membership and start monitoring your personal information please follow the steps below:

- Ensure that you **enroll by: 9/30/20** (Your code will not work after this date.)

Monitor Your Accounts

In addition to enrolling in the above offered services, we encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity. Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

You have the right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a security freeze on your credit report. In order to request a security freeze, you will need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, military identification, etc.);
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

As an alternative to a security freeze, you have the right to place an initial or extended “fraud alert” on your file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Instances of known or suspected identity theft should also be reported to law enforcement and your state Attorney General. This notice has not been delayed by law enforcement.
