Specifically, I am any requesting lists, tables, or data sets your agency may have compiled on the subject, going back in time as far as data is available. Such a list might include information like the date and location of the shooting, the name and agency of the officer, the name of the shooting victim, whether there were injuries or fatalities, and the legal outcome decided upon by your office, the courts, or similar.

The requested documents will be made available to the general public, and this request is not being made for commercial purposes. In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not.
